Eggless Dishes

When eggs are high a few recipes in which they are absent will be welcomed at this season.

Black Cake

Take a cupful of brown sugar, four tablespoonfuls of butter, a half cupful of cocoa, dissolved in a little hot water in the cup, and fill up the cup with milk. Add 1 ½ cupfuls of flour and a teaspoonful of soda, dissolved in a tablespoonful of water. Bake in a sheet. Cut in small squares after icing.

Ginger Cookies

One cupful each of brown sugar and lard, 1 ¼ cupfuls of molasses, a third of a cupful of vinegar, one teaspoonful of soda, dissolved in the vinegar, a teaspoonful of cinnamon, a teaspoonful of salt and a tablespoonful of ginger. Mix with flour to roll.

# Now & Then

**The Golden Belt, Grinnell  
May 8, 1886**

Freight is not received at our depo that is consigned east of K. C.

Mesdames Troutman and Rickman are gardening on the south side to-day.

T. E. Hutchins informs us that inside of thirty days we will see two business houses on his lot. Bully for you, Tom.

There came near being a fire at the Arlington House a few days ago – a lamp exploded – but the proper action at the proper time checked it.

The company have ordered a Stover wind mill for our south side well. That gentlemanly railroad agent, E. P. Bradshaw, Esq., is the agent for the mill.

Strange some people never can think of town improvements till the example is set before them. They are trying to raise money by subscription for a windmill on the other side.

There will be no church tomorrow on account of sacramental services at Buffalo Park, at which services Rev. Wellar will preside. Church every Sabbath after at 11 o'clock.

In this issue will be found a notice from our postmaster, regarding Sunday hours. All should be prompt in getting their mail on Sunday, as other people want rest on Sunday as well as yourself.

Peterson & Schmidt is the name of the new firm that will commence the erection of a 32x48 livery and feed stable next week, on the lot across the street west from the well. Gus and Gus are well known here, and our people are proud to have them take an interest in the town.

They had quite a blow-up – rather blow-down – at Hoxie t'other day. Considerable damage done to property.

Mrs. Bradshaw's father has been visiting her the past week, from Ellsworth. We understand he and Brad are thinking seriously of spending money in South Grinnell.

We wish to inform the people of Grinnell and vicinity that the *Belt* was started to work for the interest of our town and country. It has never until now had a chance to say much in favor of the town, and now it will show its full force. ### Sen. Moran Highlights Snow Storms in Western Kansas on Senate Floor

U.S. Senator Jerry Moran (R-Kan.) this week spoke on the Senate floor to highlight the snow storms that hit Kansas and surrounding states over the weekend, destroying crops and killing livestock.

"These storms are another vivid reminder of the challenges faced each day by farmers and ranchers trying to produce a crop or raise cattle," Sen. Moran said. "In agriculture, a family's economic situation can change at a moment's notice. A weekend weather event causes a simple inconvenience for most people - for ag producers, it is the difference between having a crop to harvest or having nothing to sell at the end of the year."

About 75 percent of the cattle on feed in the United States are located in the area hit by the storm. Feedlots are reporting that the death loss will be in the thousands of head. This impact comes only weeks after wildfires in Kansas destroyed ranches and killed thousands of cattle.

## Governor Signs Disaster Declaration for Late Winter Storm

Gov. Sam Brownback signed a State of Disaster Emergency Proclamation May 3 for 29 Kansas counties affected by a severe winter storm, heavy rain and flooding April 28 and continuing.

Counties named in the declaration are Bourbon, Cheyenne, Cherokee, Crawford, Decatur, Finney, Gove, Grant, Greeley, Hamilton, Haskell, Kearny, Labette, Lane, Logan, Marshall, Morton, Neosho, Norton, Rawlins, Scott, Seward, Sheridan, Sherman, Stanton, Stevens, Thomas, Wallace, and Wichita. This includes several counties named in a verbal declaration issued April 29.

The winter storm generated blizzard-like conditions with strong winds and heavy snowfall in the western third of the state, averaging from one to 14 inches. The highest accumulations ranged from 24 to 30 inches with drifts up to 10 feet. All main highways in the western third of the state were closed and other travel was nearly impossible. The storm brought down numerous power lines and caused other utility damages, leaving thousands of Kansans without power.

In addition to the winter storm, heavy rain caused flooding and flash flooding in the eastern portion of the state. A widespread area received approximately two to four inches of rainfall, causing flooding in many rural areas that damaged homes and made travel difficult.

Joint federal and state Preliminary Damage Assessments are expected to begin this week to determine if there are sufficient damages to warrant a request for a federal disaster declaration.

Joseph Yanez-Perez had some good runs as he placed sixth in the 800m at 2:39.07, set a PR of 5:39.45 for fifth place in the 1600m run, and placed fourth in the 3200m run with a time of 13:08.87.

The 4 x 100m relay ran the best 4 x 100 of the season of 50.26 run by Austin Patmon, Dylan Spresser, Austin Rivera, and Dawson Spresser. The boys also had a season best 4 x 400m relay of the year of 4:07.37 for fifth place with Dylan Spresser, Dawson Spresser, Nolan Ritter, and Austin Patmon running.

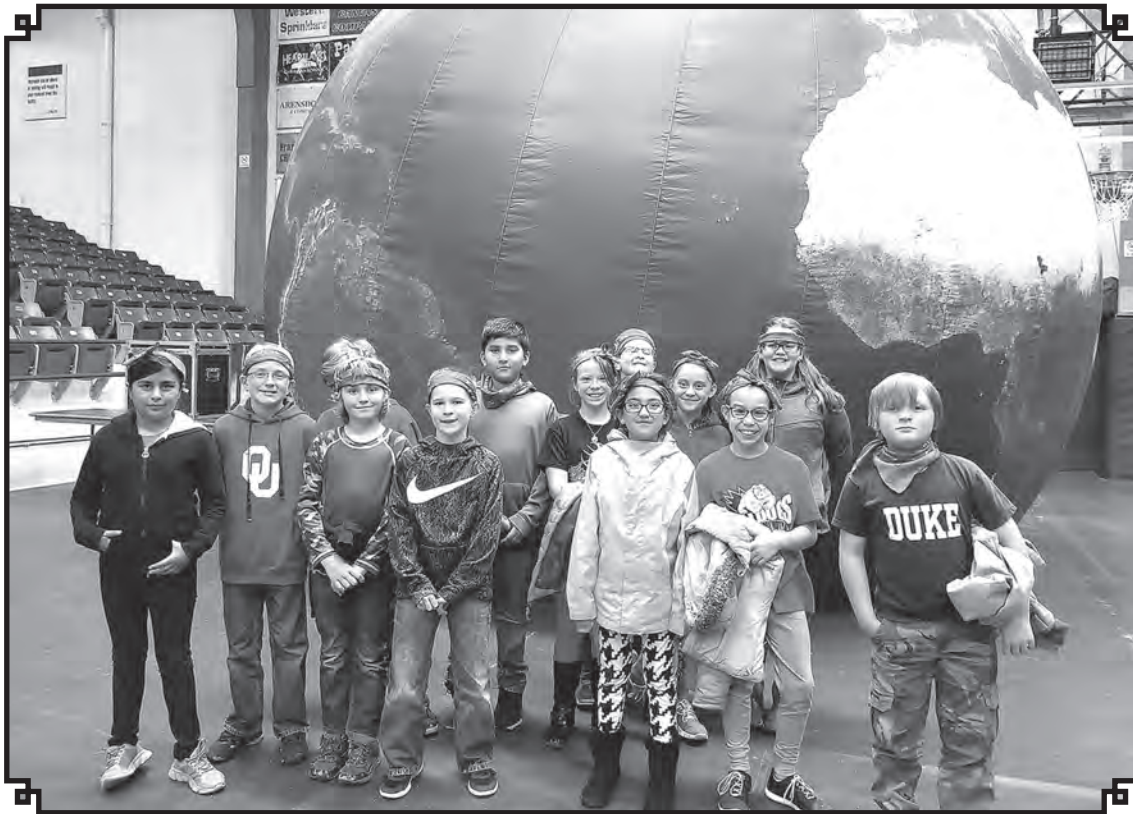

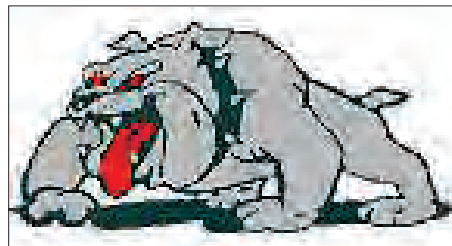

# Farm News

### Kansas Crop Progress and Condition

For the week ending May 7, 2017, temperatures averaged below normal for the second consecutive week, according to the USDA's National Agricultural Statistics Service. Most counties in the State received up to one inch of rain, however the northeast and northwest counties received little to none. Effects of recent snowfall and freezing temperatures were still being assessed. There were 2.0 days suitable for fieldwork. Topsoil moisture rated 0 percent very short, 1 short, 69 adequate, and 30 surplus. Subsoil moisture rated 0 percent very short, 6 short, 79 adequate, and 15 surplus.

**Field Crops Report:** Winter wheat condition rated 10 percent very poor, 17 poor, 30 fair, 37 good, and 6 excellent. Winter

wheat jointed was 96 percent. Headed was 59 percent, behind 70 last year, but ahead of the five-year average of 51.

Corn planted was 45 percent, behind 61 last year and 56 average. Emerged was 20 percent, behind 36 last year and 28 average.

Soybeans planted was 4 percent, near 5 last year, and behind 9 average.

Sorghum planted was 1 percent, equal to last year, and near 2 average.

Cotton planted was 1 percent, equal to last year, and near 5 average.

Alfalfa hay first cutting was 6 percent complete.

**Pasture and Range Report:** Pasture and range conditions rated 1 percent very poor, 3 poor, 22 fair, 61 good, and 13 excellent.

Stock water supplies were 0 percent very short, 2 short, 78 adequate, and 20 surplus.

### Early Spring Freeze to Kansas WHEAT

The weekend of April 29 – May 1 was very challenging to the Kansas wheat crop, especially in the western portion of the state. Over that period, anywhere from 1 to more than 21 inches of snowfall covered the majority of western Kansas, which corresponds to roughly 40% of the wheat acreage in the Wheat State.

The snowfall was also accompanied by below-freezing temperatures during a long period of time.

During the mornings of April 30 and May 1, minimum temperatures ranged from 27 to 31°F in the western third of the state. While temperatures did not reach extreme low levels, they held below freezing for extended periods of time, ranging from zero hours in central Kansas to as many as 21 hours in Wallace County during the April 29 – 30 period, and 24 hours in Tribune during the April 29 to May 01 period. This area about 30-32 degrees.

Wheat injury due to cold temperatures is more likely if it occurs repeatedly and if it is windy at night. Such conditions were experienced over the course of April 29 – May 1. During this period, we observed near below-freezing temperatures three consecutive nights and wind speeds of more than 40 miles per hour for more than 6 consecutive hours. The three consecutive nights with below-freezing temperature reduces the chances that wheat can escape freeze injury by having tillers that emerged at different times or wheat flowers within the same head pollinating at different times.

A cold spell during the spring at earlier stages of wheat development, when a minimum of 2-3 inches of snowfall is present and

entirely covers the wheat crop, it is often positive as it buffers cold damaged from temperatures lower than 32°F due to insulation. This is particularly true during the winter months, when the wheat stem has not started to elongate.


However, the snowfall events observed during the April 29 – May 1 period were heavy due to a high moisture content, and in many cases had the wheat lying flat on the ground. In some cases, the entire plants might have simply lodged without actually breaking the stems, a case in which the crop might stand back up again in the near future after the snow melts. In other cases, however the sheer weight exerted on top of the wheat crop might have caused the stems the break in many fields causing another source of yield loss in addition to the cold temperatures.

At least one week to 10 days will be needed to properly assess the situation, after the snow melts away. The yield loss will depend on stage of crop development, severity of stem breaking, and number of hours of below-freezing temperatures observed.


Yield losses due to stem breaking are generally lower if the crop is at boot stage (when it still has time to compensate


with late tillers) as compared to a crop at anthesis or early stages of grain development. Similarly, the crop at boot stage is also more protected from cold temperatures than a crop at or near anthesis. Thus, larger yield losses from the heavy snow and below-freezing temperatures might be expected in parts of the state where the crop is near anthesis (flowering) as than where the crop was still at boot stage.

Possibly, fields in the northwest corner of the state where the crop was mostly at boot stage might still produce a decent crop, depending on the severity of stem breakage. In this situation, the majority of the yield loss should come from stem breaking due to the heavy snow, but the long period of time at below-freezing temperatures might also contribute to any possible yield loss. These speculations are based on our understanding of wheat response to different stresses, and the actual damage will need to be assessed on a field-by-field situation after the snow melts away. 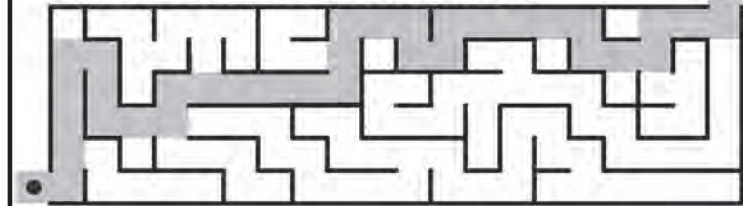

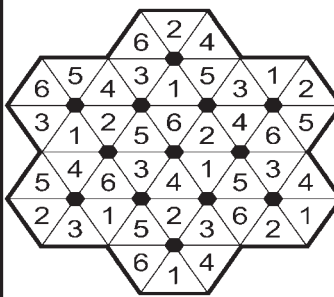
