# SHERIDAN COUNTY GIRLS VOLLEYBALL TEAMS STEP IT UP BIG FOR THEIR SCHOOLS

The Lady Indians were on a mission at Oakley High School this past Saturday, October 22. They came home with a Sub-State Championship and advanced to the KSHSAA State Tournament to be played this weekend, October 28 and 29 at Emporia.

Only three teams came into the Sub-State competition with winning records: Hoxie, Hill City, and Rawlins County. Top-seeded Hoxie began the tourney facing familiar opponent-eighthseeded Decatur Community (Oberlin.) The Lady Indians advanced to the semi-finals with a two-game victory over the Red Devils. A spectator commented, "Wow those Hoxie girls sure looked tough in that one."


The Lady Indians next played the Lady Plainsmen from Oakley in the semi-finals. Oakley came in seeded fifth, and advanced to the semis with a two-game victory over Trego Community (WaKeeney) in the first round. The Hoxie girls defeated Oakley in two games, 25-16 and 25-10, to advance to the final.

Hill City was the second seed and advanced to the semi-finals by beating seventhseeded Leoti-Wichita County in two games. The advanced to the championship match by defeating third-seed Rawlins County (Atwood) in two games. Rawlins County made it to the semis with a two-game victory over sixth-seed Ellis.

The Lady Indians defeated Hill City in the championship by winning in three games. Hoxie won game one 25-17, but lost game two 25-23. Coach Lichelle Baar's team kept on fighting in game two. They were down for most of that game, tied it up 23-23, but Hill City scored the final two points, forcing game three to decide the championship and the ticket the state tourney. Hoxie finished strong in game three, scoring 25-18 to clinch





Cross and Flame Parish


This week I had the pleasure of meeting someone from Malaysia. Now it just so happens that when I was in the eighth grade, I did an in-depth report on that country, which is just south of India. What a beautiful place! The countryside is filled with green rolling hills and majestic mountain ranges; the ocean is a deep dark blue, and the beaches are a beautifully contrasted white. There are beautiful trees that line the ocean front, and fields of indigo, which is the chief export of Malaysia. (Thank you eighth grade geography!) The cities there are modern and the architecture is stunning and artful. Kuala Lumpur is the nation's capital, and it is a constant buzz with live music and shows, and has some of the tallest buildings in the world. I can remember when I was doing that report, how I longed to see that land, how I

longed to one day travel there. What an interesting concept, to long for a place that I have never been. Have you ever felt that before? Sometimes I stand on my porch with a cup of coffee, watching a spring storm roll in, and I am hit with that blast of cool air, and the smell of rain, and I get this deep sense of longing. Longing to go somewhere, even if I don't know where it is. Longing to meet people, even if I don't know who they are. Longing to have some meaningful experience, even though I can't imagine what it might be. It is a somber feeling, a feeling as though I am missing out on something, as though there is some place, or some thing that I was meant for, that I was born for, and I am in the wrong place.

God created us to live in a garden, and to be in perfect relationship with Him. Now I won't try to over spiritualize this, but I think that garden symbolized our perfect relationship with God, and each other, and the Earth, and when Adam and Eve were cast out of the garden, they became foreigners, in a foreign land. That imprint, that feeling, has been passed down through the generations, and now, even if we are standing in the place of our birth, we still long for home. A home that we have never really known. We long for that perfect relationship, and as we travel through this life, there is something inside of us, that longs to return to that place. I don't know about you, but I take great comfort in that. That means that all of those times in my life when I felt like I didn't belong, when I felt like an outcast, when I felt like there was no place for me, that essentially, I was right. Because, I am not home, I am a foreigner, I am a traveler that is passing through on my way home, and my heart longs for it, my soul thirsts for it, and my flesh hungers for it.

We have a God who knows

us. A God who knows about our longing, and He has done something amazing for us. He has made a way for us to return to that place. He has constructed a road that we can go down, that leads us back to that place that we long for. That road is His son Jesus, and it was built with His sacrifice on the cross. This is where it gets exciting, that road is open to all who wish to go down it. It is free, without toll, to all those who would put their hope, and their lives, in Jesus. Our home lies at the end of that road, the home that we long for, and the people that we long to meet, and the meaningful experience that we long to have. The deepest longings of our hearts can be fulfilled, and we weary travelers can at last come home. So, the next time you see that spring storm rolling in, the next time you feel that tug on your heart, to go where you have never been, just relax, and smile, give your life to Jesus, and think to yourself, "I'm on my way!"



# Flavor of Game

Game should never be washed or soaked in water, which is true of any meat; if it has been carefully dressed it is only necessary that is should be well wiped with a damp cloth inside and out. All game birds should be plucked and drawn as soon as possible after killing. Remove the pin feathers, singe by holding over a blazing paper on the stove. Remove the head and feet and don't forget the oil bag from the tail.

The real game lover prefers the gamy taste rather than spices or seasonings that destroy that flavor.

If the fishy taste is not liked, parboil the birds in water with a slice of onion before the broiling or roasting.

Quail and partridge being white meat should be cooked well done, using care not to

dry it and lose its flavor. Duck, snipe, grouse, squab and woodcock have dark meat so should be served rare. All meats should be steaming hot when served. When trussing birds, use string rather than skewers as they tear the delicate flesh.

The breasts of game during the process of cooking should be wrapped in bacon, or thin salt pork, slitting it to keep it from curling, fastening on with toothpicks. As game lacks fat it should be well basted while roasting. Serve it with perfectly sliced and browned potatoes.

Venison should be cooked as one does mutton and served rare, allowing 10 to 12 minutes to the pound. Serve with spiced grape jelly or currant jelly.

Avoid game that has hung too long, as serious digestive troubles may result from such meat. Birds that are torn with shot will not keep for any length of time.










Bulldogs 46-0 by the end of the third quarter.

Producers have a number of opportunities to increase their understanding of the impact of the veterinary feed directive at meetings across Kansas this fall offered by K-State Research and Extension.

"The veterinary feed directive (VFD) will change the steps producers will need to take to provide antimicrobials in feedstuffs," according to Sandy Johnson, extension beef specialist for KSRE. "Planning ahead will be key to adjusting to the new procedure."

January 1, 2017 is the date that all the changes associated with the new regulation will go into effect. To prepare, producers need to become familiar with the regulation and the associated procedures.

K-State Research and Extension in cooperation with KSU College of Veterinary Medicine will be presenting information at a number of sites across the state to help producers, feed distributors and veterinarians understand the details.

### 'Thank an American Farmer or Rancher' Makes the Farm-to-Food Connection

"Thank an American Farmer or Rancher," a Thanksgiving-themed activity for pre-K to first-grade students, helps teachers explain where food comes from, courtesy of the American Farm Bureau Foundation for Agriculture. Through this activity, teachers also ask students to write, draw or create thank you letters or cards for America's farmers.

A free lesson plan and a letter from a farmer, suggestions for books to read, class discussion ideas and more are available online.

"Most Americans have never been to a farm and didn't even grow up near one, but they are ready to learn more about where their food comes from," said American Farm Bureau Federation President Zippy Duvall. "'Thank an American Farmer or Rancher' is a fun classroom activity that helps young learners make the connection between farms and ranches and the food they eat." Classroom ideas include:

· Complete a free sample lesson from Farm a Month and read a free sample letter from a pumpkin farmer, followed by a discussion about farming in America.

Pull up a picture of a Thanksgiving Day plate or ask students to name common holiday foods such as turkey, cranberries, green beans, potatoes and stuffing, then discuss the agricultural origins of each item.

· Have students in groups research online to discover where ingredients such as pumpkins, butter, sugar and wheat come from. Give each group one ingredient; don't tell them what the final product is going to be. Have students present where their ingredient is from and then have the class as a whole guess what the recipe is for!

• Invite a local farmer into your classroom to discuss how he or she produces food, fiber or energy.

Letters written by students as part of the activity will be given to real farmers and ranchers in January at AFBF's Annual Convention.

# USDA Announces Loans to Benefit Small-Scale Operators

Options Help More Beginning, Small and Urban Producers Gain Access to Credit

The U.S. Department of Agriculture (USDA) today announced the availability of a streamlined version of USDA guaranteed loans, which are tailored for smaller scale farms and urban producers. The program, called EZ Guarantee Loans, uses a simplified application process to help beginning, small, underserved and family farmers and ranchers apply for loans of up to \$100,000 from USDAapproved lenders to purchase farmland or finance agricultural operations.

USDA today also unveiled a new category of lenders that will join traditional lenders, such as banks and credit unions, in offering USDA EZ Guarantee Loans. Microlenders, which include Community Development Financial Institutions and Rural Rehabilitation Corporations, will be able to offer their customers up to \$50,000 of EZ Guaranteed Loans, helping to reach urban areas and underserved producers. Banks, credit unions and other traditional USDA-approved leaners, can offer customers up to \$100,000 to help with agricultural operation costs.

EZ Guarantee Loans offer low interest rates and terms up to seven years for financing operating expenses and 40 years for financing the purchase of farm real estate. USDA-approved lenders can issue these loans with the Farm Service Agency (FSA) guaranteeing the loan up to 95 percent.

USDA is providing a 90-day period for the public to review and comment on program improvements. To review program details, visit www.regulations.gov, reference RIN 0560-AI34 and follow the instructions to submit comments.

More than half of all FSA loans go to new farmers and more than a quarter to underserved borrowers. FSA also offers loans of up to \$5,000 to young farmers and ranchers though the Youth Loan Program. Loans are made to eligible youth to finance agricultural projects, with almost 9,000 young people now participating. # AGRICULTURAL CONSERVATION EASEMENT PROGRAM APPLICATION DEADLINE SET FOR NOVEMBER 25, 2016

The U.S. Department of Agriculture's (USDA's) Natural Resources Conservation Service (NRCS) is now accepting applications the Agricultural for Conservation Easement Program (ACEP). Created under the 2014 Farm Bill, this program provides funding for the purchase of conservation easements to help productive farm and ranch lands remain in agriculture and protect critical wetlands.

Kansas state conservationist Eric В. Banks said, "Conservation easements provide many public benefits Kansans, including protection of open spaces, wildlife habitat, and wetland preservation. We encourage private landowners, Indian tribes, and non-governmental organizations to contact their local NRCS office to apply." There are two programs under ACEP, each with a different application process. Vesting the NRCS office will ensure the applicant receives guidance on the correct application process.

The goal of ACEP is to protect land devoted to food production and wildlife habitat from being converted to non-agricultural uses. ACEP is a voluntary program for landowners or tribal governments that allow them to leave a conservation heritage for their family and community. Landowners can chose between the ACEP-Agricultural Land Easements (ALE) or ACEP-Wetland Reserve Easements (WRE) enrollments options. ALEs protect the long-term viability of the nation's food supply by preventing conversion of productive croplands and grasslands to non-agricultural uses. The WRE component restores wetlands to provide habitat for wildlife, including threatened and endangered species; improve water quality by filtering sediments and chemicals; reduce flooding; recharge groundwater; and protect biological diversity.

Kansas has approved a Wetland Reserve Easement Reservation of Grazing Rights Option under ACEP-WRE for fiscal year 2017. This option is for selected counties in central and western Kansas. Landowners should check with their local USDA Service Center to see if this enrollment option is available for their county. Landowners in these counties can select an enrollment option for length of time as well as for Reservation of Grazing Rights. The selection for a Reservation of Grazing Rights will result in a 25 percent reduction in the easement payment, in addition to any other reductions to the easement payment per enrollment option as applicable.

NRCS provides technical and financial assistance directly to private and tribal landowners to restore, protect, and enhance wetlands through the purchase of conservation easements. Eligible landowners can choose to enroll in a permanent or 30-year easement. Tribal landowners also have the option of enrolling in 30-year contracts.

NRCS staff will work with applicants to help them through the application process for WRE. Land Trusts in Kansas will work with landowners to help them through the application process for ALE and provide one-on-one assistance to create the conservation easement that works best for their farming or ranching operation.

All WRE applications will be rated according to the easement's potential for protecting and enhancing habitat for migratory birds, fish, and other wildlife. Eligible applicants will be compensated with a payment rate comparable to the local land use value. Those rates are posted on the Kansas NRCS Web site. ALE conservation easements payment is determined by an appraisal process completed on the property.

It is important that applicants provide accurate records of ownership and ensure they have established a record of ownership with USDA's Farm Service Agency. Application information is available at your local USDA Service Center and at www.nrcs.usda.gov/GetStarted.

Applications can be submitted at any time, but to be considered for 2017 funding opportunities, applications in Kansas must be received by November 25, 2016. Applications are currently being accepted for both agricultural land and wetlands reserve easements. Please contact your local NRCS office or conservation district office for specific information for your county.

The EPA did not announce a new date for the hearing, which was set to examine the potential carcinogenicity of the popular herbicide.

CHARTER ORDINANCE

NO. 34

A CHARTER ORDINANG

A CHARTER ORDINANCE EXEMPTING THE CITY OF HOXIE, KANSAS, FROM K.S.A. 12-4112 AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECT RELATING TO COURT COSTS ASSESSED IN THE HOXIE MUNICIPAL COURT AND AN ORDINANCE REPEALING CHARTER ORDINANCE NO. 31

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HOXIE, KANSAS:

Section 1. The City of Hoxie, Kansas, a third class city, by the power vested in it by Article 12,

Section 5, of the Constitution of the State of Kansas hereby elects to exempt itself from and making applicable to it the provisions of K.S.A. 12-4112 insofar as the same relates to the assessment of court costs in Municipal Court cases in the City of Hoxie, Kansas. The following substitute and additional provisions as hereinafter set forth in this Ordinance shall be applicable to the City of Hoxie, Kansas. This Charter Ordinance is pursuant to the home rule power of the City of Hoxie, Kansas, in the above statute is part of a uniform enactment nor applicable uniformly to all cities in the State of Kansas.

Section 2. The Municipal Judge of the City of Hoxie, Kansas, is hereby authorized and empowered to assess the following amounts as court costs, said amounts to be due and payable upon a finding of guilty, or a plea of guilty, a plea of no contest, forfeiture of bond or a diversion for any crime in the Municipal Court for the City of Hoxie, Kansas. Said sum shall be assessed over and above any amount of fine. The assessment for court costs shall be as follows:

a. A sum of \$108.00 shall be assessed for every traffic infraction committed in the City of Hoxie.

b. The sum of \$108.00 shall be assessed for every non-traffic infraction and misdemeanor crime in the City of Hoxie, Kansas.

Section 3. The Municipal Judge in any Municipal Court case may waive the court costs as the Judge shall deem fit.

Section 4. Charter Ordinance No. 29 of the City of Hoxie, Kansas, is hereby repealed.

Section 5. This Ordinance shall be published once each week for two consecutive weeks in the Sheridan Sentinel, the official City newspaper.

Section 6. This is a charter ordinance and shall take effect sixty-one (61) days after its final publication unless a sufficient petition for a referendum is filed as provided in Article 12, Section 5, Subdivision (c)(3) of the Constitution of the State of Kansas, in which case the ordinance shall become effective upon approval by a majority of electors voting at an election held on the ordinance.





Or your Local Paper Today! A PROPOSITION to amend the bill of rights of the constitution of the state of Kansas by adding a new section thereto, relating to the public right to hunt, fish and trap wildlife.

HOUSE CONCURRENT RESOLUTION NO. 5008

Be it resolved by the Legislature of the State of Kansas, two-thirds of the members elected (or appointed) and qualified to the House of Representatives and two-thirds of the members elected (or appointed) and qualified to the Senate concurring therein:

Section 1. The following proposition to amend the constitution of the state of Kansas shall be submitted to the qualified electors of the state for their approval or rejection: The bill of rights of the constitution of the state of Kansas is hereby amended by adding a new section to read as follows:

"§ 21. Right of public to hunt, fish and trap wildlife. The people have the right to hunt, fish and trap, including by the use of traditional methods, subject to reasonable laws and regulations that promote wildlife conservation and management and that preserve the future of hunting and fishing. Public hunting and fishing shall be a preferred means of managing and controlling wildlife. This section shall not be construed to modify any provision of law relating to trespass, property rights or water resources."

Section 2. The following statement shall be printed on the ballot with the amendment as a whole:

"Explanatory statement. This amendment is to preserve constitutionally the right of the public to hunt, fish and trap wildlife subject to reasonable laws and regulations. The right of the public to hunt, fish and trap shall not modify any provision of common law or statutes relating to trespass, eminent domain or any other private property rights."

"A vote for this proposition would constitutionally preserve the right of the public to hunt, fish and trap wildlife that has traditionally been taken by hunters, trappers and anglers. This public right is subject to state laws and rules and regulations regarding the management of wildlife and does not change or diminish common law or statutory rights relating to trespass, eminent domain or private property."

"A vote against this proposition would provide for no constitutional right of the public to hunt, fish and trap wildlife. It would maintain existing state laws and rules and regulations governing hunting, fishing and trapping wildlife."




