\$10,000 Grant Awarded to Hospital

The Sheridan County Community Foundation recently awarded a \$10,000.00 Hansen Community Fund grant to the Sheridan County Hospital to assist in the purchase of mini split heating/cooling units for the Long Term Care Facility during its September grant cycle.

Hospital CEO Niceta Farber stated, "The purpose of this project is to have a supplemental unit that will coincide with our existing temperature control system for our Long Term Care residents. This will allow [residents] self-control to accommodate for the sometimes fluctuating outside temperatures."

SCCF encourages organizations to submit applications to www.gnwkc.org/hansen-grant for funding consideration by the first day of each month (rolling deadline).

Six categories are considered with making

grants.

Education: Enhances the learning environment and expands opportunities for students. Provides increased self-reliance on personal life skills and workforce capability.

Health Care: Ensures access to quality health care services and promotes healthy life practices.

Community Services & Security: Enhance access to social services needed for individuals of special needs and supports systems to provide community disaster relief and general community emergencies.

Conservation & Environment: Support efforts to improve and maintain high air and water quality, appreciation for our natural environment and enhances economic and social benefits of outdoor resources.

Arts & Culture: Provide cultural and artistic opportunities to enhance the

quality of life for residents and to encourage tourism and the exchange of ideas.

Community Beautification: Support efforts to improve and maintain public spaces to enhance community pride and encourage socialization among residents.

Closing Prayer recited, Closing Ode sung, and Regent closed the meeting. Hostess for October meeting is Rita Schwarz.

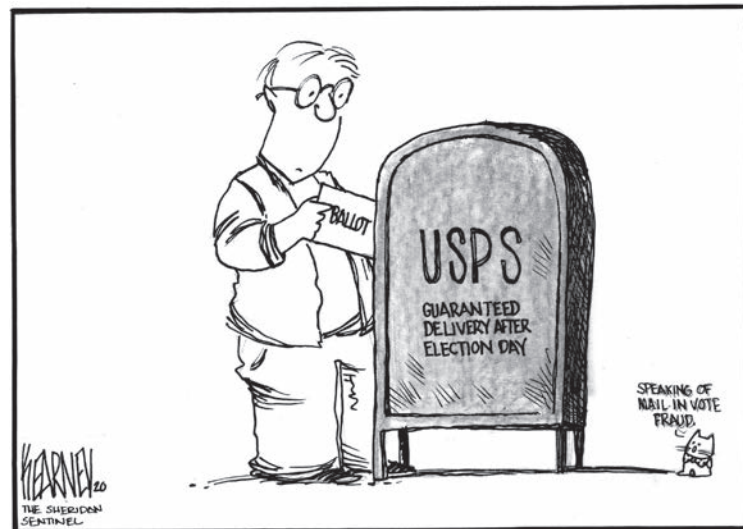

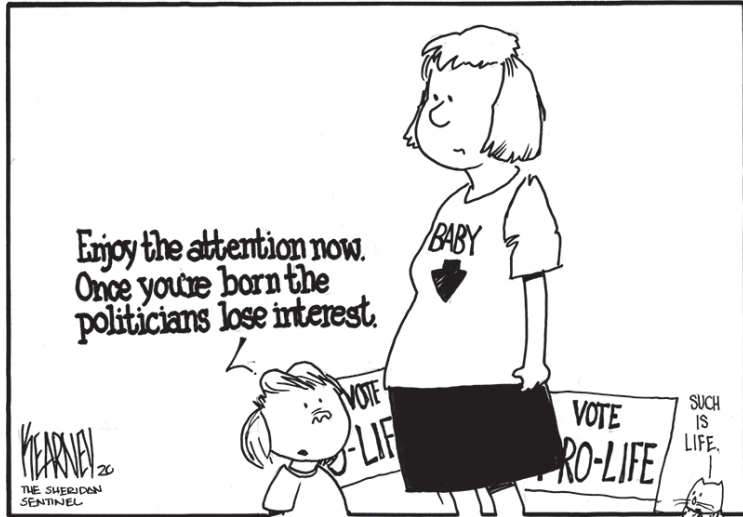

FDA Takes Actions to Help Lower U.S. Prescription Drug Prices

Final Rule, Guidance Fulfill Plan for Safe Importation of Certain Drugs Originally Intended for Foreign Markets

Today, the U.S. Department of Health and Human Services and the U.S. Food and Drug Administration took actions to help provide safe, effective, and more affordable drugs to American patients as part of the Safe Importation Action Plan, fulfilling the aspect of the July Executive Order on drug pricing to complete the rulemaking to allow states to import certain prescription drugs from Canada.

The final rule implements a provision of federal law that allows FDA-authorized programs to import certain prescription drugs from Canada under specific conditions that ensure the importation poses no additional risk to the public's health and safety while achieving a significant reduction in the cost of covered products to the American consumer. The final guidance for industry describes procedures drug manufacturers can follow to facilitate importation of prescription drugs, including biological products, that are FDA-approved, manufactured abroad, authorized for sale in any foreign country, and originally intended for sale in that foreign country.

"Today's action is an important part of FDA's priorities to promote choice and competition. The Safe Importation Action Plan aims to clearly describe

procedures to import drugs that would lower prices and improve access while also maintaining the high quality and safety Americans expect and deserve," said FDA Commissioner Stephen M. Hahn, M.D. "The FDA will continue to assess and act on opportunities to increase competition in the prescription drug market and help reduce the cost of medicines."

The rule allows states (including the District of Columbia and territories), Indian tribes and – in certain future circumstances – pharmacists and wholesalers, to submit importation program proposals to the FDA for review and authorization. An importation program can be co-sponsored by a state, Indian tribe, pharmacist or wholesaler. Referred to as Section 804 Importation Programs, these programs will be managed by the respective sponsor and any co-sponsors and authorized by the FDA to facilitate the importation of certain prescription drugs that are approved in Canada and, with appropriate labeling, meet the conditions of an FDA-approved drug application. Eligible prescription drugs would have to be relabeled with the required U.S. labeling and undergo testing for authenticity, degradation and to ensure that the drugs meet established specifications and standards. These programs will also have to demonstrate significant cost reductions of

the covered products to the American consumer.

The final guidance issued today describes procedures for a drug manufacturer to obtain a National Drug Code (NDC) for certain FDA-approved prescription drugs, including biological products and combination products, that were originally manufactured and intended for sale in that foreign country. The use of an additional NDC for these products may allow greater flexibility for drug companies to offer these products at a lower price than what their current distribution contracts require. Prescription drugs, including biological products, imported under the pathway described in the final guidance could be available to patients in a variety of settings, including hospitals, health care providers' offices or licensed pharmacies, and would include the FDA-approved labeling (including prescribing information).

The FDA, an agency within the U.S. Department of Health and Human Services, protects the public health by assuring the safety, effectiveness, and security of human and veterinary drugs, vaccines and other biological products for human use, and medical devices. The agency also is responsible for the safety and security of our nation's food supply, cosmetics, dietary supplements, products that give off electronic radiation, and for regulating tobacco products.

2nd Amendment Protects 'Fundamental Constitutional Right'

A federal appellate court panel erred by upholding New Jersey's ban on magazines that hold more than 10 rounds of ammunition, Kansas Attorney General Derek Schmidt told a federal appeals court.

On September 1, a three-judge panel of the U.S. Court of Appeals for the Third Circuit upheld a New Jersey law that criminalizes possession of a magazine carrying more than 10 rounds. Schmidt last week joined 17 other state attorneys general in seeking a rehearing by the entire appellate court. In August, a different federal appellate court, the U.S. Court of Appeals for the Ninth Circuit, struck down a similar California law, concluding that it was in conflict with the Second Amendment.

"[W]e are talking about an enumerated, fundamental constitutional right," Schmidt and the other attorneys general wrote in a brief filed last week. "While some may write the Second Amendment off as a relic of a bygone era, in reality, the ability to defend one's self is extremely important to millions of Americans."

Schmidt said Kansas has an interest in helping courts uniformly apply the proper constitutional standard to protect the right to keep and bear arms.

Seniors Can Receive Food Bundles from Sheridan County Farmers

Hoxie and Selden and Sheridan County Kansas--Low-income Kansas seniors may be eligible for a program that provides bundles of unprocessed fruits and vegetables and honey from local farmers in selected counties throughout the state.

To be eligible to receive Kansas Senior Farmers Market Nutrition Program food bundles, the following criteria must be met:

To be eligible to receive KSFMNP checks, the following criteria must be met:

1. Age: A senior must be 60 years old or older on the day the money is issued.

2. Income level: A senior's annual gross household income (before taxes are withheld) must be at or below 185% of the federal poverty level. For example, a household of one must have an annual gross income at or below \$23,606 or a monthly gross income at or below \$1,968.

Applications for the Kansas Senior Farmers Market Nutrition Program will be available starting on Saturday, October 3, 2020 at the Indian Creek Apartment office, 401 Pine, Hoxie, KS (1 block east of Dollar General). Seniors may apply on-site from 10 am to 1 p.m.

Funds are limited and benefits will be provided on a first-come, first-served basis. For more information about the Kansas Senior Farmers Market Nutrition Program, call Lori Cressler at 785-675-2358 and leave a message with your phone number. Calls will be returned promptly.

The next delivery date is scheduled for Tuesday, October 6th at the Indian Creek Apartment office. Food bundles contain fresh, nutritious, unprepared, locally grown fruits, vegetables, locally produced honey and herbs for human consumption that are produced in Kansas under normal growing conditions.

The Senior Farmers' Market Program is a project of the U.S. Department of Agriculture (USDA) Food and Nutrition Service (FNS). The program is coordinated by the Kansas Department of Health and Environment (KDHE), which is collaborating with local partners to identify and distribute bundles to eligible seniors.

The program is currently available in the following counties: Cheyenne, Decatur, Gove, Logan, Norton, Rawlins, Sheridan, Sherman, and Trego Counties.

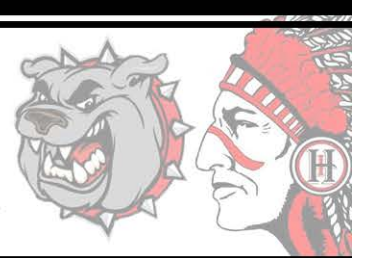

2020 Organic Certification Cost Share Program Now Accepting Applications

The Kansas Department of Agriculture has funds available for the National Organic Certification Cost Share Program (NOCCSP). Through this program, farms, ranches and businesses that produce, process or package certified organic agricultural products may be reimbursed for eligible expenses.

The purpose of the NOCCSP is to defray the costs of receiving and maintaining organic certification under the National Organic Program. For FY 2020-2023, the U.S. Department of Agriculture's Farm Service Agency is revising the reimbursement amount to 50 percent of the certified organic operation's eligible expenses, up to a maximum of \$500 per scope. Scopes include the areas of crops, livestock, wild crops and handling (i.e., processing). This change is due to a limited amount of funding available and will allow a larger number

of certified organic operations to receive assistance.

FSA awards the NOCCSP funds to eligible state agencies that serve as administering entities who work directly with organic operations to reimburse organic certification costs. The current period of qualification for organic operations seeking reimbursements is from Oct. 1, 2019, through Sept. 30, 2020. Applications are now being accepted through Dec. 15, 2020, or until all funds are expended, whichever comes first.

It is the mission of KDA to support all facets of agriculture, including lending support to those who wish to market and sell their products as certified organic. Kansas Hog Inventory Unchanged

Kansas inventory of all hogs and pigs on September 1, 2020, was 2.09 million head, according to the USDA's National Agricultural Statistics Service. This was unchanged from September 1, 2019, but down 5% from June 1, 2020.

Breeding hog inventory, at 175,000 head, was unchanged from September 1, 2019, but down 3% from last quarter. Market hog inventory, at 1.92 million head, was unchanged from last year, but down 5% from last quarter.

The June - August 2020 Kansas pig crop, at 942,000 head, was down 4% from 2019.

Sows farrowed during the period totaled 88,000 head, down 2% from last year. The average pigs saved per litter was 10.70 for the June - August period, compared to 10.90 last year.

Kansas hog producers intend to farrow 87,000 sows during the September - November 2020 quarter, down 5,000 from the actual farrowings during the same period a year ago. Intended farrowings for December 2020 - February 2021 are 84,000 sows, down 3,000 from the actual farrowings during the same period a year ago.

Kansas Crop Progress and Condition

For the week ending September 27, 2020, there were 6.7 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 12% very short, 37% short, 50% adequate, and 1% surplus. Subsoil moisture supplies rated 11% very short, 34% short, 54% adequate, and 1% surplus.

Field Crops Report: Winter wheat planted was 35%, ahead of 26% last year and 25% for the five-year average. Emerged was 10%, near 9% last year and 7% average.

Corn condition rated 5% very poor, 12% poor, 28% fair, 42% good, and 13% excellent. Corn mature was 84%, ahead of 69% last year, and near 81% average. Harvested was 29%, near 25% last year, but behind 35% average.

Soybean condition rated 4% very poor, 11% poor, 35% fair, 40% good, and 10% excellent. Soybeans dropping leaves was 68%, well ahead of 39% last year, and ahead of 51% average.

Harvested was 10%, ahead of 1% last year and 5% average. Sorghum condition rated 3% very poor, 8% poor, 28% fair, 49% good, and 12% excellent.

Sorghum coloring was 96%, ahead of 90% last year, and near 94% average. Mature was 45%, ahead of 33% last year, and equal to average. Harvested was 6%, near 5% last year and 9% average.

Cotton condition rated 3% very poor, 11% poor, 39% fair, 41% good, and 6% excellent. Cotton bolls opening was 54%, ahead of 41% last year and 45% average. Harvested was 1%, near 2% average.

Pasture and Range Report: Pasture and range conditions rated 7% very poor, 18% poor, 36% fair, 35% good, and 4% excellent.

Kansas Corn, Ethanol Would Benefit from Bill

The Kansas Corn Growers Association (KCGA) welcomed the Next Generation Fuels Act of 2020, introduced today by Rep. Cheri Bustos, D-Ill. The bill is the first step toward implementing a High Octane, Low Fuel Standard that would remove current barriers to increased ethanol use by giving automakers the tools to produce engines optimized to run on higher-octane fuels. The bill recognizes the high octane, low carbon benefits of corn ethanol by establishing a new 98 Research Octane Number (RON) standard for gasoline and requiring that sources of additional octane result in a 30 percent reduction in greenhouse gas emissions.

"After more than a year of

discussions and negotiations, we finally have a bill that sets the standard," KCGA's Vice President of Market Development and Public Policy Josh Roe said. "Simply put, the bill sets the stage for automakers to produce engines optimized to run on high octane fuels containing up to 30% ethanol, limits the amount of harmful aromatics in unleaded gasoline and requires EPA to put ethanol on a level playing field with unleaded gasoline."

Ethanol is the most efficient and cost-effective octane source, providing the greatest efficiency gains at the least cost to drivers while displacing the most harmful components of gasoline.

KCGA, working with the National Corn Growers Association (NCGA) and other industry partners, will advocate for the bill as it moves through Congress.

"This is a key advancement in fuel ethanol and something that brings tangible benefits to farmers, ethanol producers, car manufacturers, motorists and the environment," Roe said.

Farm Bureau Launches Think F.A.S.T. for Youth

The American Farm Bureau has launched a new online youth safety course, Think F.A.S.T. (Farm & Ag Safety Training). The program was developed to help youth aged 14 to 17 think through and learn about avoiding common safety hazards on the farm and ranch. The program and related materials focus on general safety, leadership and critical thinking skills applied to technical and agriculture-specific contexts. The training is available at no cost to anyone interested in learning about farm safety (Farm Bureau membership is not required for access).

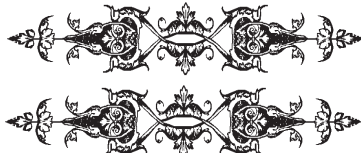
Kansas Cattle on Feed Up 6 Percent

Kansas feedlots, with capacities of 1,000 or more head, contained 2.47 million cattle on feed on September 1, according to the USDA's National Agricultural Statistics Service. This inventory was up 6% from last year.

Placements during August totaled 540,000 head, up 23% from 2019.

Fed cattle marketings for the month of August totaled 470,000 head, up 9% from last year.

Other disappearance during August totaled 10,000 head, unchanged from last year.

Wes Bainter called the meeting to order.

Pratt stated he had been on the webinar pertaining to the designation of the Chisholm and Western Trails as national historic trails. Pratt stated the group has been working on this project since 2009 but the proposed bill has never been submitted. Pratt will send another letter to Jerry Moran's office with a copy to KNRC about the Commissioners' concerns with the trail interfering with Sheridan County landowners. Pratt discussed the history of the Hoxie Feedlot, the airport project and the Neighborhood Revitalization Program. Pratt believe everything is tied together with great things going on in the county.

A letter of support was requested to Alissa Ice at Kansas Housing Resources Corporation in support of the City of Hoxie's endeavor to secure Moderate Income Housing (MIH) funding to assist with paying off specials on three lots in Sunrise Addition. Welshshon made a motion to approve the letter of support, seconded by Wes Bainter. Carried 3-0. Bracht asked about voting delegate for the KAC meeting. More information is requested on what the person would be voting on.

Bracht advised the Board that Melissa Wachendorfer, Public Health Nurse/Administrator would be having surgery on Monday, September 21, and would be out for six weeks.

Welshshon stated she had gone to the hospital after last week's meeting and spoke with Niceta Farber and Mike O'Dell and the hospital is not anywhere ready for the motion that was made at the September 9 meeting. The hospital does not want Public Health. They want the immunizations. Welshshon stated we need help in Public Health now, not in six months, and that last week she felt blindsided with the motion that had been made. Welshshon continued that she was shocked that Wes Bainter made the motion and that the cart was put before the horse. Welshshon made a motion to rescind the motion made September 9, 2020 by Wes Bainter approving an LPN being provided by the Sheridan County Hospital. Joe Bainter seconded the motion. Welshshon made a motion to approve the warrant as presented, seconded by Joe Bainter. Carried 3-0.

Wes Bainter made a motion to approve the September 11, 2020 payroll as presented, seconded by Joe Bainter. Carried 3-0.

The minutes of September 9, 2020 were approved as corrected on a motion by Wes Bainter and second by Welshshon. Carried 3-0.

Joe Herskowitz from Road & Bridge came to the table. Herskowitz shared the following information:

- Hoxie Feedyard will provide the water for work on the feedlot road and a blade will be parked there. The road will try and be kept safe for truck traffic during harvest.

- Studley street project will be completed this week.

- The horizontal baler in recycling has seals that are leaking oil. They will be sent to Colby to fix. There is also a hose that needs replaced, which will be done in the winter. Recycling is picking up a lot more cardboard and a truck should come this week.

- Internet is needed at recycling. Cost from NexTech is \$52.00/mth for slower speed or \$90.00/mth for faster. Herskowitz will go back to Nex-Tech and talk about Wi-fi and being able to use what is at the County Shop.

- Herskowitz presented a map with main roads on it. School bus routes, mail routes, and roads with residences will be marked.

Welshshon stated that the sealed bids that had been presented the prior week appeared to have been opened. Welshshon stated, and Wes Bainter, agreed that all sealed bids should be sent/given directly to the County Clerk.

At 10:00 Wes Bainter opened the 2021 Budget Hearing. Jim Myers, CPA, stated that mill levy went to 62.210, down from 68.957 in 2020. The actual taxes levied dropped by \$500,000. There were no comments or questions from the guests. Wes Bainter made a motion to approve the 2021 Sheridan County Budget as presented. Welshshon seconded the motion. Carried 3-0.

The 2021 Rural First District #1 Budget Hearing was opened. The mill levy for the Fire Department went to 3.8 for 2021, up from 3.75 mills in 2020. Taxes levied are up by \$4,000. Wes Bainter questioned Wade Tremblay, Fire Chief, on how the equipment is and where is the Fire Department headed. Tremblay stated they have good personnel and a good fire department. They currently have two lease purchase vehicles and the department is currently trying to save to purchase trucks outright. The department is trying to get a grant for new bunker gear. Bunker gear has to be replaced every seven years, and current bunker gear is probably 10 years old. Tremblay stated equipment wise, everything is good. Wes Bainter made a motion, seconded by Welshshon to

approve the 2021 Rural Fire District Budget. Carried 3-0

Jerol DeBoer from Penco Engineering came to the table and distributed the bridge report that was submitted to the state the previous week. The report lists which bridges need replaced or repaired. DeBoer stated the state has a program that will help fund replacement of bridges. Wes Bainter stated that some of the bridges could be put to low water slabs, but the state will not fund those. There is a permit process, but one design could be used in multiple locations. DeBoer stated no low water crossings on any main roads. For low water crossings, the County would be looking at approximately \$100,000. Engineering fees would be \$10,000 - \$15,000 for the first one and probably \$7,500 for additional ones. The Division of Water Resources approves the low water crossings, but no approval is needed from the state. DeBoer had presented the engineering cost estimate from Penco for the feedlot road. DeBoer stated the bridge is not in bad condition but is very narrow and getting overstressed every day. Joe Bainter feels with increased speed and traffic, more stress could be caused to the bridge. DeBoer stated this would bump up the cost of the project. Penco Engineering cost estimate for the feedlot road project is \$20,000, which includes the bid letting and presentation to the Sheridan County Board of Commissioners. The Board thanked him for coming.

Buck Driggs from Driggs Design came to the table with

their cost estimate for the feedlot road. Driggs gave a history of the firm, which was started in 2013 and discussed their bid. Driggs stated that with a 6" top, there should be an 8-10-year lifespan before the County would have to do too much to it, then we would have to seal, repair cracks, etc. Driggs Design bid of \$53,745 included the bid letting and presentation to the Sheridan County Board of Commissioners as well. The Board thanked him for coming.

Wes Bainter made a motion, seconded by Joe Bainter, to approve the low estimate from Penco Engineering for the design services for the feedlot road. Joe Bainter seconded the motion. Carried 3-0

Joe Bainter made a motion, seconded by Wes Bainter, to amend the agenda to include Dana Hess, Sheridan County Dispatch. Hess advised the Board that there is currently a full-time and part-time position open. Hess would like there to be a higher starting wage for someone coming in with experience. The Board advised her to come up with a schedule and bring to the next meeting.

The following warrant was approved and signed:

No further business, Wes Bainter made a motion to adjourn, seconded by Joe Bainter. Carried 3-0. The next regular meeting will be Wednesday, September 23, 2020 at the regular time and meeting place.

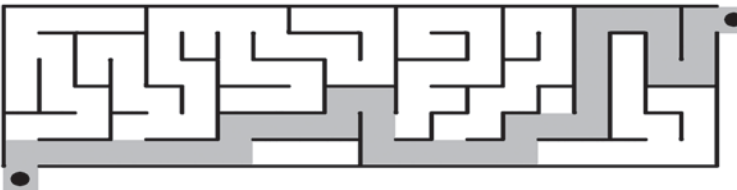

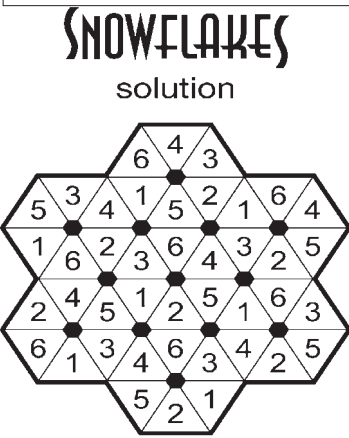
