TAXPAYERS' REPORT

Last Thursday, July 2, we held a special meeting of the Commissioners to discuss the latest executive order by Governor Kelly regarding a new round of regulations. These regulations are restricting the lives of Kansans with the justification being to help contain the spread of the COVID virus. The saving grace of this executive order was that the implementation and enforcement of this order was left to the individual counties.

To say that I have received numerous comments from Sheridan County residents that we DID NOT want to require face coverings, as well as we DID NOT want any local enforcement, is an understatement!

Based on the wishes of the residents of Sheridan County, we issued Resolution #20-115. This resolution is printed in this issue of *The Sheridan Sentinel* in its entirety.

The governor's executive order represents a glaring example of government overreach and exercising authority that the governor *does not have!*

In my work as your County Commissioner, I am fully aware that I work for and with the guidance of *all* the residents of Sheridan County. In this case, the residents of Sheridan County expressed their views and we acted accordingly. This is the way government is supposed to work.

At our regular Wednesday Commissioner Meeting we continue to work on the formulation of the 2021 Budget.

The comment I receive the most is regarding the \$7.1 million that Sheridan County has in reserve funds at the banks. The question is, *why and how* we got taxed for such an excessive amount of money that Sheridan County *did not need* to operate the County and to maintain all the County services? The answer is very simple, many people in the position of imposing property tax never feel comfortable that the County has enough money on hand and always need more tax dollars every year!

Even though county government is not a business, it needs to be run and operated like a business because all the principles of budgeting, operating, and spending are the same. With this in mind, I will be proposing that we decrease our levy tax amount by \$1 million and use some out of reserves. *Can we afford this???*

Absolutely!

Let's take the Road & Bridge Department and analyze the amount of money and how it is being spent and the results thereof. We will rebuild at least 50 miles of roads and probably closer to 75 miles of roads during 2020, including re-elevate, sand, and add culverts as needed. We will accomplish this with County workers and private contractors working together. The cost for this road rebuilding will be about \$660,000. The 2020 Road Department Budget is \$3,454,200. You can see that the necessary analyzing is never the case; i.e. that the amount of money spent should equal the results.

We have a new program going at the Road Department where we are working together with County road workers and private contractors and we are getting outstanding results and many, many miles of roads are getting fixed. We are spending a whole lot less money, which means we don't need to tax as much as we have during the past several years. We have a group of road workers in our Sheridan County Road & Bridge Department that are getting the job done!!

I have received lots and lots of compliments from our rural residents and their appreciation for the work that is being done and actually fixing the roads!!

We have a new culture at our Road Department, which is Job One. We are all working for the taxpayers and residents of Sheridan County and our taxpayers and residents deserve the very best roads. Another big improvement that we have made is that we have contracted with individuals who are doing the mowing. The cost of this program for the entire year of 2020 is going to be about \$350,000. Here again, an enormously cost-effective program to get the road ditches mowed all across Sheridan County. The taxpayers and residents of Sheridan County deserve to have county roads that are mowed and continue to be mowed throughout the year.

WWII Veteran Flag Travels 358 Miles to Rest in Grinnell

How many of us can say, "A garage sale changed my life?" Not many I am sure, but for St. Joseph, MO resident, Stacy Swinney, a garage sale find set her on a pursuit that would end up becoming a life-changing moment of the humble kind and she did not even have to make a purchase.

The garage sale was a storage unit sale at which was an old World War II ceremonial flag. Stacy stated the people were going to throw the flag away, so she took it home with her. The American flag was in a triangular zipped plastic protective casing. Stacy had no clear idea what she was going to do with it, but upon bringing it home she unrolled part of it, and the start of her journey was revealed. Curled up in the flag was a man's driver's license, vintage child's photograph, and several other items. Ms. Swinney knew that this flag had a home, and it was not hers to keep.

Stacy began researching where the flag and items could have come from. Having a little experience in genealogy as a hobby, Stacy used FindAGrave.com first, which revealed that the name on the Colorado driver's li-

cense, John W. Douglass, belonged to a World War II Veteran who was buried in a little cemetery in Grinnell, Kansas. Stacy used many online sites to try and find living descendants of Mr. Douglass, but to no avail. Stacy then took to Facebook, searching for anything that might put her in touch with someone in Grinnell, KS. The town's Facebook page popped up, so Stacy placed a photo of the flag,

School Receives Grant for Family Partnership Program

Hoxie Community Schools is excited to announce a new program, funded, in part, through a grant from the Greater Northwest Kansas Community Foundation.

Families with children between the ages of birth to school entry are eligible to participate in this new Family Partnership Program. The goals of this program are to ensure that families have access and information about community and school resources and to help children enter school ready to learn.

Teachers have noted that many children are coming to school lacking some of the skills that they need to be successful - for example: the ability to hold writing instruments correctly, pay attention and follow directions, or speak clearly and have conversations. "Technology companies have done a great job of selling products to parents with the promises that their app or video will teach their children the skills they need, when, in fact, what children need is to

have parents and caregivers who have conversations with them, read them books, include them in family projects and chores, and provide them with paper, pencils, markers, crayons, etc. There is no app that will provide these experiences that children are missing out on," remarks Cyndie Aumiller, Pre-K teacher.

In an effort to help and support parents, Linda Frazey, recently retired reading specialist, will visit with families periodically and bring them books and information. "Mrs. Frazey is generously volunteering her time for this program because she believes that our youngest children need

these types of experiences. She is the perfect mentor and advisor for parents!" says Ms. Cyndie.

Each visit will last approximately 45 minutes and children will receive a new book at each visit that is theirs to keep. Mrs. Frazey will also help parents focus on their child's strengths and preferences as they check off developmental milestones and abilities and she will schedule visits every 3 to 6 months, depending upon the child's age. "Originally, we planned for all of these visits to take place in the family's home; however, with coronavirus concerns and to insure that we are providing a safe location for

both the families and Mrs. Frazey, we will have all of the visits in the nursery of the Presbyterian Church. This will allow us to maintain a disinfected environment for the visits. Hopefully, we can start having home visits in the future."

If you have an infant or toddler, live in the Hoxie School District, and are interested in setting up a visit, please call the Hoxie Grade School 675-3254 and Mrs. Frazey will contact you. According to Mrs. Frazey, "We are also mailing letters to those families who we know have children in this age range, so you may receive more information in the mail."

Cressler's Comments



Col. Cressler Hoxie, Mo.

In 1861, my great-grandfather A. Cressler joined the Illinois Army Company B49 Illinois Infantry. After training, he was sent to Cairo, IL, and later sent to Shiloh Battle in Tennessee. From there on to Cormouth, MS, where they defeated and captured 4000 Rebs. After that, he was in Vicksburg siege for 43 days. After Vicksburg fell, his

company and others on July 4, 1863 put the Union flag on the courthouse in Vicksburg. Later, A. was transferred from Grant's army to General Sherman's command and marched to Atlanta, GA. After that on to South Carolina, and finally after Lee's surrender, his company went on to victory, and moved to Washington, D.C.
I wonder what Granddad A. and many others would think about the thugs, deadbeats, and fools who tear down monuments, statues, and history.
Cressler's father-in-law was captured and sent to Andersonville Prison, where he starved to death. A. Cressler later came to western Kansas where he helped organize Sheridan County, and was elected to county commissioner for the term from 1892-1894. He lived in Sheridan County until his death in 1916. He was buried in Masonic Cemetery, Hoxie, KS.

Local Students Earn Distinction at Wichita State University

Wichita State University has announced the names of more than 3,700 students who were on the WSU Dean's Honor Roll for spring 2020. From Rexford, Devin J Carter, Trey M Schwarz, and Koi W Wessel were among those students.
To be included on the Dean's Honor Roll, a student must be enrolled full time (at least 12 credit hours) and earn at least a 3.5 grade point average on a 4.0 scale.
More than 2,000 students completed degrees at Wichita State University in spring 2020.
Undergraduate students who have attained a grade point average of 3.9 out of a possible 4.0 received the summa cum laude award; those with an average of 3.55 received the magna cum laude award; and those with an average of 3.25 received the cum laude.

From Hoxie, Sydney Dingler, earned a Bachelor of Science in Biological Sciences, and from Rexford, Koi Wessel, earned a Bachelor of General Studies in General Studies Biology.

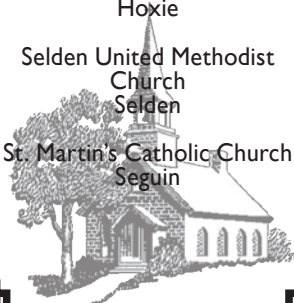

Sheridan County CDBG-CV (Coronavirus Aid, Relief, and Economic Security [CARES]) Act CDBG #20-CV-059 Plan

Sheridan County has received a Community Development Block Grant to help local for-profit businesses retain jobs for low-to-moderate income people. CV funding can assist these businesses with issues triggered by the Covid-19 virus and when no other funds are available.

Sheridan County will begin accepting applications for CV assistance beginning on June 25, 2020. Applications will be accepted for a 30 day period ending on July 25, 2020. Applications can be picked up and dropped off at the Sheridan County Clerk's office on or after June 25, 2020 at 925 9th Street, Hoxie, Kansas.

After the July 25, 2020 deadline, the County will review applications and award funds based on review of demonstrated need. Businesses will be notified in writing of the outcome.

Should additional funding remain after the first 30 day deadline, Sheridan County will advertise for a second 30 day application period.

Urban Moos Killed While Walking Down Stairs
Saturday morning at the M. A. Wagoner home southwest of Seguin occurred a sad death when Urban Moos, a young man who was not many years past his majority, was shot and instantly killed by the discharge of a shotgun.

The census is still happening! With the many other issues in the news, don't forget that Kansas needs to get a complete count for the 2020 census.

It is not too late to complete the information for your household. You can go online to 2020census.gov to respond. If you are not comfortable responding online, you can either fill out the paper form you should have received in the mail, or call, 1-844-330-2020 (1-844-468-2020 for Spanish language).

For every Kansan that is not counted, our state, and by trickle down, our hometowns lose more than \$2,000 *every year* for 10 years. So, for each person counted, Kansas gains \$20,000 in federal dollars over the coming decade. These funds are critical for schools, highways, and a host of other programs and projects that affect our daily lives. The census also is used to determine our representation in Washington.

In short, it's important! Be sure to count every person in your household, from newborn babies born on or before April 1, to grandparents, other relatives or friends who live with you.

If you have a friend or neighbor you suspect might need help completing the census, offer to help or share the phone number above.

Currently Kansas is at just over 65% response rate. It's better than the national average, but not as good as it was in 2010 or as good as Kansas needs it to be.

Kansas Approved for Online EBT Purchasing

Starting in September Kansans will have the option to purchase groceries online using Kansas Benefits Card.

Governor Laura Kelly today announced that the United States Department of Agriculture approved the Department for Children and Families (DCF) proposal to offer Kansas food assistance recipients the option of purchasing groceries online using a Kansas Benefits Card also known as an EBT card.

"The COVID-19 pandemic has presented enormous challenges - especially for our vulnerable families," Governor Kelly said. "We will continue to work with our federal and local partners to make critical resources - like food and nutrition - accessible, to keep families healthy and safe."

DCF is working with its EBT partner to test the new system to ensure there are no disruptions to the normal EBT transaction process. The agency expects testing to be done during the summer with full implementation of online purchasing expected in September.

"We know the pandemic has made it difficult for those receiving food assistance to travel to grocery stores to purchase food," Howard said. "This new online purchasing program provides those families the flexibility to safely purchase groceries online."

In addition, the agency will announce partner vendors closer to implementation.

Kansas currently has more than 185,000 individuals who receive food assistance benefits totaling \$265 million annually.

"I work in various mediums such as acrylics, watercolors and pencil," explains Hutfles-Boardman. "And, before I earned by Bachelor of Fine Arts Degree from Kansas State University, my first formal art instruction came from Kenneth Mitchell at Colby Community College."

Following college, Boardman entered the design and advertising world as a layout and campaign artist before teaching art classes in schools and arts councils throughout Kansas City, Wichita and Topeka. She also has experience illustrating children's books and spent four years teaching private classes in her year-round art studio.

Historic Senate Confirmation of the 200th Judge

On Wednesday, June 24, 2020, U.S. Senator Jerry Moran (R-Kan.) voted to confirm Cory T. Wilson as a United States Circuit Judge for the Fifth Circuit, marking the 200th judge confirmed during President Donald Trump's Administration - the most Senate-confirmed judges at this point of a presidency in that last 40 years.

- John Broomes was confirmed as a District Judge on the U.S. District Court for the District of Kansas in April of 2018.
- Holly Teeter was confirmed as a United States District Court Judge for the District of Kansas in August of 2018.

Governor Kelly Announces FY 2021 Allotment Plan

Governor Laura Kelly announced today her final plan for adjustments to the FY 2021 budget, which begins on July 1, 2020.

"COVID-19 has created new economic challenges for our state," said Governor Kelly. "However, the hard work that was done last year to restore fiscal stability prevented this unprecedented situation from being much worse. While we had to make hard choices, I'm pleased that this plan will preserve critical funding for Kansas schools, our infrastructure, and business recruitment tools. Kansas will undoubtedly feel the economic effects of COVID-19, but by preserving our core services, we will be better positioned for economic recovery and to continue growing when this virus is behind us."

Kelly's allotment plan totals a little more than \$704 million and includes items that will require approval from the Legislature when they return in January. The largest portion of the plan proposes to delay the \$132 million payment to the Pooled Money Investment Board for FY 2021 and requests an additional loan of \$132 million, for a total of \$264 million.

"I want to thank Larry Campbell and his team for their work identifying items that minimize the direct impact on Kansans, and I look forward to working with the 2021 Legislature to put together a bipartisan budget, said Governor Kelly."

Allotment plans are provided for under K.S.A. 75-3722 when deemed necessary and beneficial to the state by the Director of the Budget.

Governor Declares Drought Emergency, Warnings and Watches for Kansas Counties

The Governor's Drought Team examines conditions; fire dangers and encourages Kansans to be mindful of the state's worsening conditions

Tuesday, July 7, Governor Kelly issued Drought Declarations for Kansas counties with Executive Order #20-54. The declaration includes 74 out of 105 counties either in an emergency, warning or watch status.

"Unfortunately, the majority of the state of Kansas has been considered in drought or abnormally dry conditions for the past several weeks, which has led to high risk of fire hazard," said Governor Kelly. "This declaration will allow affected communities to access the water they need. I encourage Kansans to continue to be mindful of drought conditions, and work to minimize the threat of fires across the state."

The drought declaration placed 13 counties in emergency status, 18 into a warning status and 44 into a watch status. This action was recommended by Earl Lewis, Director of the Kansas Water Office and Chair of the Governor's Drought Response Team. Most of the state has received fewer than 70% of its normal rainfall since January, and many southwestern counties have received less than half of their normal precipitation.

"It has been a very dry winter and spring, especially in western Kansas, and forecasts into the coming summer months predict higher temperatures and fewer chances of precipitation," said Lewis. "The Governor's Drought Response Team will continue to monitor the situation closely as future outlooks call for drought persisting and make recommendations to the Governor as necessary."

Counties who are in emergency stage are eligible for emergency use of water from certain state fishing lakes due to the Kansas Water Office (KWO) Memorandum of Understanding (MOU) with the Kansas Department of Wildlife Parks and Tourism (KDWP).

Individuals and communities need to contact KWO for a water supply request prior to any withdrawals from lakes. They will in turn be referred to the appropriate KDWP office to obtain the necessary permit to withdraw the water.

This Executive Order shall remain in effect for those counties so identified until rescinded by Executive Order or superseded by a subsequent Executive Order revising the drought stage status of the affected counties. Effective immediately:

- Declare a Drought Emergency, Warning or Drought Watch for the counties identified below;
- Authorize and direct all agencies under the jurisdiction of the Governor to implement the appropriate watch or warning level drought response actions assigned in the Operations Plan of the Governor's Drought Response Team.

The Governor's Drought Response Team will continue to watch the situation closely and work to minimize the effects the drought has on Kansans.

USDA Dairy Safety-Net Program Signup to Begin

Income-over-feed margin for April triggers second payment for 2020

The U.S. Department of Agriculture's Farm Service Agency (FSA) announces that Dairy Margin Coverage (DMC) safety-net signup for 2021 coverage will begin October 12 and will run through December 11, 2020. DMC has already triggered payments for two months for producers who signed up for 2020 coverage.

"If we've learned anything in the past six months, it's to expect the unexpected," said FSA Administrator Richard Fordyce. "Nobody would have imagined the significant impact that current, unforeseen circumstances have had on an already fragile dairy market. It's during unprecedented times like these that the importance of offering agricultural producers support through the delivery of Farm Bill safety-net programs such as DMC becomes indisputably apparent."

The April 2020 income over feed cost margin was \$6.03 per hundredweight (cwt), triggering the second payment of 2020 for dairy producers who purchased the appropriate level of coverage under the Dairy Margin Coverage (DMC) program. The April margin reflects a more than a \$3 drop from the March \$9.15 cwt. income over feed cost margin.

As of June 15, FSA has issued more than \$100 million in much-needed program benefits to dairy producers who purchased DMC coverage for 2020.

RESOLUTION #20-115

A RESOLUTION REGARDING THE USE OF FACE MASKS

WHEREAS the Governor of Kansas has issued Executive Order 20-52 mandating the use of face masks in all public areas effective 12:01 a.m. Friday, July 3, 2020; and,

WHEREAS such mandate includes criminal and/or civil penalties for persons who do not wear face masks in public; and,

WHEREAS Kansas law authorizes the Board of County Commissioners to issue orders relating to public health that include provisions that are less stringent than the provisions of an executive order effective statewide issued by the Governor; and,

WHEREAS the board has consulted with the local health officer and following such consultation concerning the implementation of the use of face masks, as mandated in the Governor's executive order, however, the board is not in favor of the mandated mask order because of concerns for compliance, enforcement and civil liberties.

The board has determined that presently the mandated use of face masks in public is not necessary to protect the public health and safety of the county; and,

WHEREAS, while the wearing of masks in public will not be mandated, it is strongly recommended to do so for the following reasons;

- The transmission of the virus from asymptomatic patients is decreased by 80% when wearing a mask.
- If 80% of a population wears a mask, it has the same effect as a complete shutdown of the economy.
- States and communities that have implemented broad mask usage have seen sustained drops in the rates of infection.
- States and communities without broad mask usage have seen an increase in infection rates.
- Broad use of masks in public indoor spaces will decrease the likelihood of the business closures due to infections.
- Broad use of masks will increase the likelihood of opening schools and having sports for our children.
- There are no good treatments for the virus and only three primary ways of prevention which are:
 - Hand hygiene
 - Social distancing
 - Mask wearing in public indoor spaces and outdoors when unable to social distance
- Due to the decreased infection rate, broad mask usage would essentially be an economic stimulus by keeping our businesses open and our community healthy.

WHEREAS as of this date there have been five confirmed and two probable cases of coronavirus in Sheridan County;

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Sheridan County, Kansas, sitting both as the Board of Commissioners and as the Board of Health of the Count, determines that the use of face masks in public is not required in Sheridan County, Kansas.

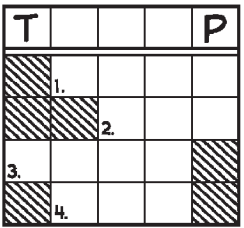

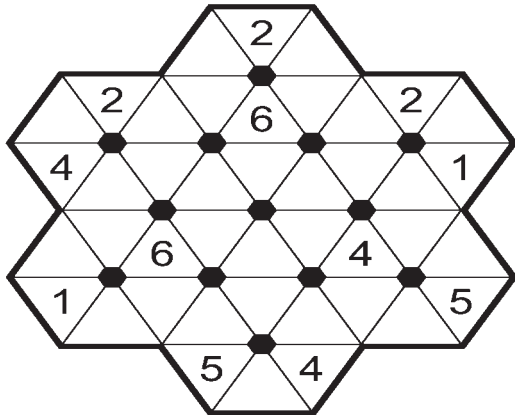

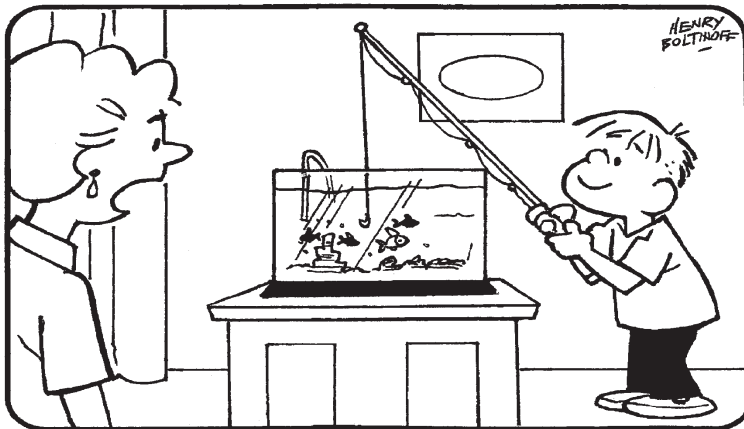
